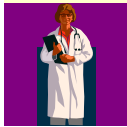

RHCs transitioned to the new Medicare Administrative Contractors in 2009 and some clinics will have to face another change. Proposed RHC regulations threaten the very existence of many rural health clinics and threaten to reduce payments to all RHCs by limiting collections to cost. Threats are everywhere as well as opportunity. Electronic Medical Records Stimulus payments could total almost \$64,000 per provider over 5 years from Medicaid or \$44,000 from Medicare over 5 years. Your clinic needs to learn how to get the money now while the government is offering the carrot and not the stick. Medicare is expanding payments for mental health services over the next four years as well. You need to be aware of the changes that effect your rural health clinic.
