

Mark Lynn, CPA (Inactive) presented on the topic at the National Association of Rural Health Clinics (NARHC) meeting and at many local and state meetings during 2017 and 2018.

EMERGENCY PREPAREDNESS

RHCs are 1 of 17 different provider groups that must establish a comprehensive Emergency Plan to address emergency situations that may occur at the RHC or in the surrounding community.

The rule requires RHCs to implement four component standards defined by CMS as:

- **Emergency Plan:** Develop an emergency plan using an all-hazards approach based on a risk assessment.
- **Policies & Procedures:** Develop and implement needed policies and procedures based on the emergency plan and risk assessment.
- **Communication Plan:** Develop & maintain a communication plan that includes provisions for coordinating patient care with the facility, across healthcare providers, and with State and local public health departments and emergency systems.
- **Training & Testing Program:** Develop and maintain training and testing programs in which the clinic will conduct drills and exercises that test the emergency plan.



HBS works with our clients to help them become and stay in compliance with RHC Emergency Preparedness regulations. We also spend a lot of time resolving condition-level deficiencies for RHCs that have not implemented or maintained their Emergency Preparedness program.
