In this webinar, we will update Rural Health Clinics on the status of Telehealth and how it can be paid by Medicare based upon the expected approval of the Phase 3 Emergency COVID-19 Response Legislation slated to be voted on this weekend. Ryan Kelly, Executive Director of the Mississippi and Alabama Rural Health Associations will provide a legislative update and an overview of the technologies that can be used to provide Telehealth services to your patients (20 minutes).
