FEASIBILITY STUDY

Healthcare Business Specialists can evaluate your current costs and billing to determine the benefits of your clinic becoming designated as an RHC.

RHC STARTUP & CONVERSION

Rural Health Clinics (RHCs) provide primary healthcare services in medically underserved rural areas and are certified under Medicare.

The purpose of the RHC program is improving access to primary care in these underserved rural areas. In turn, RHCs receive a special rate for providing Medicare and/or Medicaid services in rural areas. The special rate is meant to result in greater reimbursement for the clinic.



- Preparation of the 855A as required by Medicare
- Completion of the State Rural Health Clinic Application
- Preparation of the RHC Policy and Procedure Manual
- Conduction of a Mock Inspection of the clinic
- Preparation of the Emergency Preparedness Policy and Procedure Manual and Tabletop Exercise
- Preparation of a Projected Cost Report for Medicare & Medicaid Rate Setting
